

SWIMMING POOL RULES

1. Residents & Guest Pool Access: Access to the swimming pool at Eagle Springs is restricted to residents and accompanied guests only. Guests **MUST** be accompanied by an **ADULT** resident of the Eagle Springs community. Residents are responsible for the behavior of their guests. Residents and guests swim at their own risk, as Eagle Springs Homeowners Association, Inc. assumes no responsibility for accidents/injuries. No individual group will exceed ten (10) people (including residents) without prior notification/approval. Call during normal office hours, the phone number is 953-8702. All residents **MUST** use their Door King Access card to enter the pool area. Periodic checks may be performed by management to ensure only authorized residents and guests are using the facility.

2. Pool Hours: Mon-Wed 9:00 am – 8:00 pm

Thursday 11:00 am – 8:00 pm (pool will open late due to cleaning)

Fri – Sat 9:00 am – 8:00 pm

Sun 11:00 am – 7:00 pm

Pool use outside of these hours must be approved by management. The pool may be closed by management at other times due to inclement weather, maintenance, unsafe conditions or Board of Director approved community events.

3. Safety Rules:- Children under the age of 16 *MUST BE accompanied by an adult resident* (age 18 or above). Parents are ultimately responsible for the safety of their children.

- No running, fast walking, wrestling or games are allowed on the concrete decks around the pool. Games include throwing any objects (balls of any type, Frisbees, wet objects, etc...) into or over the pool.
- Flotation devices are **NOT** allowed beyond the life lines (diving area).
- Beach balls and pool toys (soft type) may be used in the pool.
- Swimmers are not allowed to play or hang on the rope(s) separating various sections of the pool.
- Pushing or throwing people into the pool is not permitted.
- Jumping the gate or fence is not permitted.
- Fishing from within the pool fence or on the grass adjacent to the pool is not permitted (From the dock is allowed).
- Impaired persons are not permitted in the pool area. Consumption of alcoholic beverages is highly discouraged while swimming, diving or using the slide.
- Consumption from open alcoholic bottles or cans is not permitted, please use paper/plastic cups.
- Skateboarding, roller-blades, and bicycle riding are not permitted in the pool area.

4. Pool Cleanliness and Courtesy Rules:

- Only swimmers wearing bathing suits will be allowed in the pool. **NO SHORTS!**
- **NO** pampers or diapers are allowed (“Little Swimmers”) or the equivalent are permissible).
- All trash must be placed in the proper receptacles.

- At no time shall you interfere with personnel designated by the Eagle Springs Homeowners Association, Inc. Board of Directors to manage the pool. This includes lifeguards, Pool Committee members and association staff.
- All food must be consumed in one of the two picnic areas (Eagle's Nest and/or Eagle's Roost).
- Drinks in glass containers are NOT permitted within pool area.
- No foul/profane language or loud, boisterous talk.
- Radio volume shall be kept at a level that does not disturb others.
- Smoking is only permitted in the designated area next to the Eagle's Nest.
- No pets permitted in the pool area.

5. Special Events: Special events such as private birthday parties may be held at the swimming pool using one of the two picnic areas available. Such events **MUST** be scheduled through the Eagle Springs Homeowners Association, Inc. in advance. A refundable security deposit will be required, along with signing a pool event contract. All terms of the pool event contract are binding. The Board of Directors may set policy requiring the presence of lifeguards, depending on the age and number of children at the event/party. These lifeguard(s) will be paid by the event sponsor. In some cases, the required lifeguards may be in addition to the regular lifeguards on duty.

6. Violators: Violation of the above rules will result in an initial warning to the offender. A second, or subsequent, violation will result in removal from the pool area by pool management and/or appropriate law enforcement.

Failure to comply with or interfere with personnel designated by the Eagle Springs Homeowners Association, Inc Board of Directors in the performance of their duties is considered a violation.

In addition, violators may be subject to suspension of pool privileges for a designated period, as determined by the Eagle Springs Homeowners Association, Inc. Board of Directors.

WATER SLIDE RULES

1. ALL persons must be at least 48" in height to ride the water slide.
2. Pregnant women, people with heart conditions, people with neck or back problems, and people under the influence of drugs or alcohol are NOT permitted to ride.
3. ONLY individuals wearing appropriate bathing suits may ride. Cut-off jeans, bathing suits with buckles, rivets or sharp objects may damage the slide and cause injury to others. Shoes, sandals or other footwear are also forbidden.
4. Riding position is either sitting or lying feet first and arms crossed over your chest. NO riding "head first".
5. ONLY one person may ride at a time. Chains or double riding are NOT permitted.
6. Exit the landing area as quickly as possible. DO NOT remain in the splash pool.
7. NO swimming in the splash pool area while the slide is in operation.
8. NO running or pushing on the stairs leading up the slide tower.
9. NO climbing on the slide at any time.
10. ***Slide will ONLY be operated when 4 lifeguards are on duty (1 top and 1 bottom of the slide) and the 2 remaining will cover the main pool area..***
